There's a restaurant serving international cuisine, and a snack bar. Other amenities include a gym, a library with movies, and 5 meeting rooms. The participant price is based on 3 people per room. Supplement \$ 1,040.00 for a single room and \$ 200.00 per person per stay for sharing a double.
