We will send you a receipt by email once your card has been charged. Our cancellation fees policy is as follows:

- Between booking and 20 weeks prior to departure: \$ 200.00 per person.
- Between 20 weeks and 16 weeks prior to departure: \$ 350.00 per person.
- Between 16 weeks and 4 weeks prior to departure: 40% of the participant's price per person plus added cancellation costs from our suppliers.
- Between 4 weeks and 1 week prior to departure: 60% of the participant's price per person plus added cancellation costs from our suppliers.
- Within one week of departure: 100% of the participant's price per person.

Your agreement is also an acknowledgement to us that you will not dispute any charges with your credit card company no matter if the tour takes place or your tour gets cancelled. We value you as a customer and these types of disputes are timely, costly, and only serve to drive a wedge into otherwise wonderful working relationships. If you do have concerns, we would be delighted to talk to you to resolve any issues.
